3. All employees/club members are required to:

- Co-operate with the Club Managers on health & safety matters;
- Not interfere with anything provided to safeguard their health and safety;
- Take reasonable care of their own health and safety; and
- Report all health and safety concerns to the Club Managers

### Risk Assessments

- Risk assessments are undertaken by the Club Managers
- The Club Manager or Club Chairman will approve actions required to remove/control risk
- The Club Manager will be responsible for ensuring action required is implemented and will check that the risks have been reduced/removed
- Assessments will be reviewed annually or sooner if work activity changes

### **Equipment and Handling and Use of substances**

- The Groundsman is responsible for identifying equipment needing maintenance and substances, which need a COSHH assessment (Bar Proprietor if related to the bar)
- The Club Managers will ensure that all identified maintenance is implemented and actions identified in any COSHH assessments are implemented (Bar Proprietor if related to the bar)
- Any problems should be reported to the Club Managers (Bar Proprietor if related to the bar)

### **Information**

The Health and Safety Law poster is displayed in the kitchen and leaflets & information can be obtained from the Club Managers

### **First Aid**

- First Aid boxes are located in the players bar by the main entrance, in the squash corridor and in the kitchen
- The accident book can be located on the wall inside the clubhouse by the main exit
- All our coaches and the Club Managers are First Aid trained

### **Emergency Procedures**

- Escape routes are regularly checked as part of the Club's risk assessment
- Fire alarms are monitored and serviced by Town & County and tested weekly the Club Managers
- Emergency lighting is serviced by Kingson Electrical annually and tested weekly the Club Managers
- Fire Extinguishers/Fire Blankets are serviced by Town & County annually
